Dear Supervisor Turner, Commissioner Moran, and Chairman Gonstead,

My name is Tom Grotewohl. I currently live in Kansas City, but my wife and I are moving up to the Marquette area in just a few weeks after we fell in love with the natural beauty of the region on a trip last year.

We had a lovely visit in October of 2021. The fall colors were spectacular, and we hiked along the Yellow Dog Trail very near to your township. My wife and I were astounded by the pristine environment, the lush forest as far as the eye could see, and of course the majesty of Lake Superior. Immediately we knew this was the place we wanted to live.

On our trip, we were puzzled to see signs marking the road which read, "Stop the Rocket!" When we learned what they were referring to, we were stunned: finally we had found the place of our dreams only to learn that it was under threat by the schemes of technocrats and multi-millionaires.

As we've been conducting our real estate search, we find it useful to examine the region through Google Earth satellite imagery. In this way, we discovered the huge National Mine near Ishpeming, and lakes like Lake Gribben turned orange by toxic mineral wastes, and Sawyer International Airport. Unfortunately the area we are considering for our future home becomes smaller and smaller as we learn about new threats to the health of the environment. Of course, we do not object to humans interacting with natural resources and using them to advance our civilization – but the ever-increasing

presence of such massive developments underscores an important point: though it takes only a few years to build an airport or a mine, they will continue to last for centuries and millennia even after they are no longer in service. Humans build more developments everyday, but nobody is building more nature. The trend is clear but difficult to perceive, because it happens slowly over the course of generations and entire lifetimes. It might be easy to think, "It's just a single spaceport," but if a line is not drawn in the sand, then that spaceport will only attract more development in the future, like a tumor spreading to many times its original size. That's why it's crucial to remember that we are not just responsible for protecting the present, but the future as well.

Fortunately, Google Earth also reveals something more promising: the region to the northwest of Marquette, surrounding Powell and Big Bay, is thus far uncompromised by the concrete jungle. This speaks very highly of the way you have managed the area – perhaps you already understand that a healthy natural environment is also the key to human health, not to mention happiness!

But since you find yourselves as the stewards of a beautiful and relatively untouched region, I believe you also have the responsibility to continue protecting it. I know we are out-of-towners, and perhaps it seems it is not our place to have strong opinions on the matter – but often those from outside are much better able to appreciate the merits of a place than the people who actually live there. If you grew up in a big city surrounded by cornfields as I did, you would know just how precious areas like yours truly are!

I've shared my personal story and perspective, because I'm sure you are already familiar with the more technical arguments against the rocket launch site at Granot Loma. But a few points that resonate deeply with me are these:

-Lake Superior is the largest surface area of fresh water in the world. It is also

the cleanest. You can literally get down on your knees and drink straight out of the lake, as I have done myself (crazy, I know). In a world where countries are fighting wars over access to freshwater, this is the most important resource there is. Can you imagine jeopardizing this priceless resource with contamination by rocket fuel and other industrial waste?

- -The construction of the launch site would require cutting down hundreds and likely thousands of acres of forest. All this for MAMA's most recent estimate 650 jobs (and that is likely a generous estimate) the bulk of which would be ephemeral construction positions which would vanish as soon as the project is completed. All this for an enterprise that would earn revenue equivalent to two fast food restaurants (as revealed by the IQM report). But though money and a few jobs can be made in a flash, the forest and the health of the lake would take centuries to restore.
- -Why the heck can't they build these vertical launch sites out in the desert, where not a single tree need be cut or a single family evacuated from their homes? With this fact in mind, it is hard to find any logic whatsoever in the current proposal.
- -Finally, please consider the fact that if the spaceport is constructed, people like me in search of a home will no longer consider your region. I cannot think of a worse nightmare than living near to a launch site, possibly having to be evacuated but definitely having to hear deafening ruckus and have to worry about the contamination of my water supply. All these factors surely will not reflect positively in property values in the area.

Thank you for entertaining my thoughts. I want to emphasize again that I think the Powell Township has down a fantastic service by protecting its natural resources to the extent that it has, and I trust you will continue to exercise the same good judgment in the future with regards to the rocket launch site. I understand that there are large technological interests and people with

infinitely deep pockets who will attempt to sway you against your intuition – but moments like these are an opportunity to take a heroic stand and then rest assured knowing you can sleep well at night for the decisions you've made.
