6. Call to the Public: Time for Citizens to be Heard:

Phil Bakken N4359 Lighthouse Rd, Big: Submitted a Petition for amendment Of zoning ordinance text. The board received a packet of information Regarding Prohibitions on rocket launch sites, structures, and activities. Mr. Bakken is requesting that we schedule a public meeting for September 2023.

8. Unfinished Business:

- a. Tiny house on Lake Independence. Kristen Bressette attended the meeting to give us an update on the progress with addressing this property. She reported that building codes is requiring a well and septic for the addition and that it is going to take a little longer to resolve the non-conforming structure.
- b. Non-conforming properties: Howard sent us a list of how many non-conforming properties are in Powell township with no explanation. We are going to get with Howard and get a list of the properties and see how we can incorporate those properties in the future land use map.
- c. Future Land Use. A couple of members are going to meet with Howard to discuss what his suggestions are for the changes to the future land use map. We are requesting to meet on August 5, 2023.

a. Fences: We have recently had an issue with a permit that was issued for a fence. The State of Michigan no longer has specific rules for fences. We need to enhance the current fence ordinance.
