WHEREAS, No Parking on any street or Roadway between the hours be amended to the times of 11pm to 6am for snow removal. Signs will be installed and removed by Township Maintenance Personnel.

WHEREAS, The Powell Township Agent is hereby authorized to remove any vehicle abandoned or parking upon any public highway or street in violation of the terms and provisions of this ordinance, and to take any said vehicle to the nearest garage or other place of safety. The registered owner of any said vehicle shall be promptly notified in writing of the fact of the removal and of the place to which said vehicle has been removed, where he/she may obtain the same upon payment of any and all towing and storage charges.

WHEREAS, Any person violating any of the provisions of this Ordinance shall, upon summary convictions before a Justice of the Peace, be sentenced to pay a fine of Fifty (\$50.00) dollars and costs of prosecution, such fines to be collected as like fines are now collected by law, and in default shall undergo imprisonment not exceeding thirty (30) days.
