**RESOLUTION AMENDMENT TO TOWNSHIP OF POWELL, MARQUETTE COUNTY, MICHIGAN  
SEWER RATE ORDINANCE**

The Board of Powell Township, Marquette County, Michigan, Ordains:

That the Powell Township Water and Sewer Rate Ordinance. Designated as Ordinance No. 3, adopted March 13, 2001, shall be, and the same hereby is amended as follows:

REPEALING

That portion of Section 1, under the heading Sewer Rates of Ordinance No. 3 the Powell Township Water and Sewer Rates Ordinance, as adopted March 13<sup>th</sup>, 2001, and any other Ordinance, Resolutions, Order, or parts thereof in conflict with the provisions of this Amendment, it is, to the extent such conflict, hereby repealed. This repeal shall be effective as of the effective date of the following Amendment.

AMENDMENT

That portion of Section 1, Ordinance No. 3, the Powell Township Water & Sewer Rate Ordinance under the heading Sewer Rates, as adopted December 15<sup>th</sup>, 2020, shall be, in the same hereby is amended to read as follows;

SEWER RATES

*Residents*

Sewer rates will be \$30.00 per month, per residence,

Non-service sewer fee will be \$30.00 per month, per residence.

*Business*

Monthly sewer rates for users of the Township's Sewer System, based upon the water meter readings of the amount of water consumed per month, as follows:

Sewer rates will be \$30.00 per 10,000 gallons or any portion thereof

An additional \$7 will be charged per 1,000 gallons or any portion thereof

Non-service sewer fees of \$30.00 per month per business

Minimum Monthly Bill: \$30.00

*Late Fee*

A monthly 5% late charge for any amounts 30 days past due

SPECIAL RATES

For miscellaneous services for which a special rate shall be established, such rates shall be fixed by the Township board.

Enforcement


The charges for sewer service which are under the provisions of Section 21, Act 94 Public Acts of Michigan, 1933, as amended, made a lien on all premises served thereby, unless notice is given that a tenant is responsible, are hereby recognized to constitute such lien and whenever official or officials in charge of the collection thereof shall certify annually, on September 1<sup>st</sup> of each year, to the tax assessing officer of the township, the fact of such delinquency, where upon shall be collected and the lien thereof enforced in the same manner as general township taxes against such premises are collected, and the lien thereof enforced; provided, however, where Section 21, no premises until cash deposit of not less than \$90 shall have been made a security for payment of charges and service.

Section 2: All ordinances and parts of ordinances in conflict with the provisions of this resolution amendment are hereby repealed in so far as the conflicting portions thereof are concerned.

Section 3: This Ordinance shall be published in full in the *Marquette Mining Journal*, a newspaper of general circulation in the township, promptly after its adoption, and shall be recorded in the Ordinance book of the Township, and such recording authenticated by the signatures of the Township Supervisor and Township Clerk.

Section 4: This Ordinance is hereby determined by the Township Board to be immediately necessary for the preservation of the peace, health and safety of the Township and is therefore declared to have immediate effect as of March 1<sup>st</sup>, 2020
