- A. <u>Ambulance Department:</u> D. Turner no report.
- B. <u>Emergency Management:</u> Prepared by K. Bourgeois/EMS, presented by D. Turner:
 - a. On October 3, 2024, K. Bourgeois met with the Marquette County Emergency Manager, the Red Cross Community Disaster Specialist for Northern Michigan, a Red Cross Volunteer for Marquette County, and the Marquette County Health Department Emergency Preparedness Director, all of whom are working together to survey and assess local emergency shelters in Marquette County. They toured all three township buildings, with the EMS Fire Hall listed as the main shelter, and the Township Office Building listed as the secondary shelter. They also toured the school and both churches. K. Bourgeois is not sure if there will be any official report as a result of their visit, but in their conversation, they felt the main shelters met the criteria and requirements (including backup power, Americans with Disabilities Act (ADA)-assessed restrooms, and kitchen facilities).
