- c. Fire Department: M. Anderson/Fire Chief:
 - i. There were three (3) calls since the last meeting. They were all over the Thanksgiving weekend.
 - ii. On January 6, 2026, the classroom training starts for our five trainees.
 - iii. We also received a very generous donation from the Huron Mountain Club. We hope to use it for additional costs once we get the five trainees through everything.
- d. Parks and Recreation Department: H. Shatz/Chair:
 - i. A new trail usage report is available and will be posted to our page on the town site. It's a great report and has been recording trail counts from 2021 to present. We post new data every 4-6 months to show trends. Archived data is available on request.
 - ii. Draver Park
 - 1. Bathrooms will be open as soon as we get Wi-Fi and a security system is in place. Sven Gonstead will be talking with Levi Ellis about systems that the County uses, including self-locking and unlocking doors.
 - 2. We are starting grant writing for a Passport Grant with CUPPAD for finishing touches to Draver Park to include the snack shack.
 - 3. Draver Park Ribbon Cutting will be held on June 6, 2026, at 1 p.m. Parks and Recreation will start inviting people to the event in January.
 - iii. Safe Routes to School Grant
 - 1. The Parks and Recreation Department and the Powell Township School Board is working on a route.

 - 3. This grant is worth \$600,000 dollars to improve and build new sidewalks (this grant does not require a match) that will not only be for a safer route to the school but for our entire community.
